



## **NOTICE TO BUSINESS PARTNERS REGARDING THE MERGER OF COMPANIES TOSHULIN, a.s. a TOS KUŘIM – OS, a.s.**

Dear business partners,

we hereby inform you that the company **TOSHULIN, a.s.**, ID No. 255 10 851, with its registered office at Wolkerova 845, 768 24 Hulín, registered in the Commercial Register maintained by the Regional Court in Brno, Section B, Insert 2455, (hereinafter referred to as "TOSHULIN" or "Successor Company"), has completed a corporate transformation, specifically a merger with **TOS KUŘIM – OS, a.s.**, ID No. 262 31 522, with its registered office at Blanenská 1321/47, 664 34 Kuřim, registered in the Commercial Register maintained by the Regional Court in Brno, Section B, Insert 3595 (hereinafter referred to as "TOS KUŘIM" or the "Dissolved Company").

The merger was implemented in the form of a consolidation, with the effective merger date set as January 1, 2025. TOS KUŘIM merged with its sole shareholder, TOSHULIN. This step is of a predominantly formal nature. It is the company's reaction to current customer requirements, while providing the stability and strength of a financially strong company. The merger is also a part of TOSHULIN's long-term strategic plan, aimed at streamlining and optimizing internal processes, achieving maximum flexibility, homogeneity, and consolidation of activities in the field of engineering production.

All rights and obligations of the Dissolved Company, including contractual and legal relationships, have been transferred to TOSHULIN as of the effective date of the merger. In connection with this change, it is not necessary to conclude amendments to contracts, make any adjustments, or take special measures. All obligations and business relationships remain fully intact.

This change has no adverse effect on the rights or obligations of either the Successor or the Dissolved Company.
